Request for Design Approval

Pursuant to the covenants enforced by the Ranchos de Placitas Property Owner's Association ("POA"), ALL property owners (new & existing) are required to obtain approval of the Architectural Committee ("AC") PRIOR to commencing any earthwork/excavation/pad preparation for ANY project that may affect the mandatory setback, height from natural grade, drainage, home design, minimum first floor size requirement, etc. Such requirements apply to construction including, but not limited to: building a new home, or an addition to an existing home.

The owner shall make an application for such changes by completing this form in its entirety and submitting it to the Ranchos POA AC with two sets of preliminary drawings of the proposed improvement, and any applicable review and compliance fees. The drawings should include a Plot Plan showing location of house, walls, driveway, propane and septic tanks, drainage plan and a plan proposed showing the location of the power and phone lines and other proposed improvements.

Again, absolutely no construction including earthwork shall commence until the AC has approved in writing this completed form and the final construction plans. Upon application for AC review for new construction, a \$150.00 fee is required, along with a \$2000.00 refundable compliance fee, to be refunded once construction is completed. For additions, outbuildings, etc., a \$50.00 application fee, and a refundable fee of \$500.00 is required.

PLEASE NOTE: failure to obtain AC approval prior to construction will result in a \$1000.00 fine/fee and will be pursued in Court. Also note any non-compliance noted during construction and flagrantly ignored will result in an injunction to cease construction.

Additional Stipulations:

Sanitation facilities, accessible to the workers, must be present on the property when work begins.

A refuse container or dumpster must be present on the property as soon as refuse is generated. It must be emptied as necessary to avoid the littering of neighboring properties. The property being built on must also be kept free of unnecessary litter.

When cement is to be poured, the Architectural Committee must be notified a day in advance. That way we can determine responsibility for spills that occur on the roads and are not cleaned up promptly (before it hardens).

Failure to comply with any or all of the above requirements may result in a mandatory stoppage of work on the property, and/or a partial or complete forfeiture of the compliance deposit.
